ACTIONS AT SAR CONGRESS and GASSAR BOM (Revised August 12, 2009)

State and National Dues:

July 18, 2009, GASSAR BOM, the \$3.00 continued as part of the dues structure. No overall State increases.

National for approval; State dues for Juniors be allowed. Thus it is important that Chapter Presidents and State Committee Registrants).

and \$15.00 for Juniors (\$10.00 National, with new fees. \$5.00 State). The same applies for reinstatements.

National Lifetime Membership: November 1, 2009, the National fee will increase from \$750 to \$900 for members 40 and younger, decreasing \$15.00 for each year over age 40. New application forms are forthcoming.

New Applications: Congress increased Adult application fee from \$60.00 to \$80.00 effective with applications received at National after January 1, 2010. Applications, including Junior Membership, received at National after November 1, 2009, must include the \$5.00 dues increase since these will be for 2010 membership. Thus the total amount to be submitted with application to GASSAR Registrar increases from \$108.00 to \$133.00 (includes \$30.00 National dues for 2010).



Adult Education Program on the American Revolution in Georgia

Continuing the educational emphas is on the American Revolution in Georgia, the *Georgia Revolutionary War Trail Committee* will be making six presentations for the Adult Education program at Emory University every Thursday beginning October 8th at 11:20 am -12:20 pm, at the Osher Lifelong Learning Institute at Emory. The institute is open to adults age 50 and above who pay a modest fee to enrich their lives by learning.

The classes are:

October 8th – Skeet Willingham, "Overview of the Battles of the American Revolution". Summary of the initial battles following Saratoga. And then review the decision by Cornwallis after the Battle of Brandywine to split his forces in an attempt to get greater support from the Tories in the South and discuss "The Southern Strategy".

October 15th. Dr. Hugh Rodgers. "The Battles of Augusta". This topic will focus on the two major battles which occurred in Augusta, Georgia's Capital after the capture of Savannah.

October 22nd-Larry Wilson. "Overview of the Georgia Revolutionary War Trail" along with a presentation on "Georgia Military Leaders". There will be a "Living History" of Nancy Hart (Sara Lesseur) and Mammy Kate (Betty Slayton). There will also be a brief discussion of the plans for the trail. Biographies presented on Pickens, Dooly, Clarke, Elbert, McIntosh and others like Austin Dabney.

October 29th-Bob Sapp. "Battles of the backcountry", This segment includes descriptions and discussions of the battles at "Van(n)s Creek", "Kettle Creek" and Brier Creek" giving the background of Colonel Boyd's assignment in the backcountry of Georgia and the Carolina's.

November 5th-Gordon Smith "The Battles of Savannah"; This session covers the British occupation of Savannah and the attempt by the French & Patriot forces to retake the city and ends with the evacuation by the British.

November 12th-Bill Ramsaur "Fort Morris/Sunbury/ & Midway combined with the Three Florida Expeditions, including the Frederica Naval Action". This final session covers the military activity in the Coastal Georgia area during the early years of the American Revolution.

Georgia's Revolutionary War Trail

One of the objectives of the Georgia Society SAR is freedom. to help promote, preserve and perpetuate the historic Revolutionary sites in Georgia. In implementing this objective, a current SAR project is to identify, document and publicize the ten major Revolutionary War battles that occurred in Georgia as a part of "Georgia's Revolutionary War Trail."


The Georgia Society SAR has prepared a series of eight brochures that describe Georgia's ten major battles and date and place of the Annual Celebration. The summary Trail brochure, "Major Georgia Battles in the American Revolution," includes a time-line of the key events in Georgia during the Revolutionary War, summaries of the ten major battles and photos of some of the historic sites and celebrations. Eight locations are identified on the Trail map, and the highlighted area along the Savannah River and the Atlantic Ocean reflects Georgia's Original Counties created in 1777.

"Georgia's Revolutionary War Trail" Map -

Exploring Georgia's Revolutionary War Trail, you can discover where the past can be found in the present. You can stand on the Savannah battleground where General Casimir Pulaski was mortally wounded, or visualize the naval battle in the Frederica River, or walk where Colonel Elijah Clarke fought Loyalists alongside Kettle Creek in Wilkes County. At the Fort Morris earthworks in Liberty County, you can imagine hearing Lt. Col. John McIntosh shout, "Come and take it" or imagine hearing the French cry, "Vive le roi" at the Spring Hill redoubt in Savannah.

Standing with your back to Brier Creek in Screven County, you can suppose Colonel Samuel Elbert surrounded by British Highlanders, or visualize "Light Horse Harry" Lee's cavalry during the capture of Fort Cornwallis in Augusta. You can honor the memory of Revolutionary War Patriots buried at Colonial Cemetery in Savannah, St. Paul's Cemetery in Augusta, and the Midway Cemetery in Liberty County. If you explore Georgia's Revolutionary War Trail

during the Annual Celebrations, you can hear historians describe the Revolutionary War action and see personalities who portray the men, women and children who fought for our freedom

Athens

The Athens Chapter of the Georgia Society recently was asked by Hebron Presbyterian Church in a nearby county to assist in a dedication ceremony for restored graves in the cemetery of the two hundred fourteen year old church. Time was short as the ceremony was planned for the church's annual Homecoming event, less than two weeks from the time of first notification. The Chapter accepted the challenge and in the process discovered that the cemetery held the "Scottish tombs" of at least six Revolutionary Patriots who had assisted in founding the church in 1794, soon after they moved to Georgia with Revolutionary War land grants. It is highly probable that other patriots, perhaps as many as twenty, are buried in unmarked stone tombs there. Research on that probability is ongoing.

The chapter organized a complete Grave Marking Ceremony and with assistance from compatriots from the Joseph Habersham, Lyman Hall and Button Gwinnet Chapters of the Georgia Society and the Elijah Clarke DAR Chapter joined church members, descendants and visitors in an impressive ceremony in the churchyard. Research proved the existence of six patriot graves, and a wooden model of a monument bearing the patriots' names and emblazoned with the SAR insignia was unveiled by a proud patriot descendant. Since then a Georgia granite marker has been purchased and will stand permanently near the historic stone tent-shaped Scottish tombs in which the Revolutionary War Patriots rest.

Cracking the Code on **Recruiting Notable Members**

As the chairman of the Membership Committee's Task Force For Notable New Members and Patriots, I've been challenged to figure out a way to recruit notable members. I've had negligible success myself, but I keep thinking "SOMEONE must have recruited our seventeen presidents; how did they do THAT?"

Who qualifies as a "notable new member?" Certainly, presidents do, but the list includes other government and community leaders, history teachers, and descendants of Black, Native American, and female patriots. Those of us who have tried "cold calling" patriotic authors and others whom we were "JUST SURE" would want to join our organization have generally met with a close-to-zero response rate. At times, we may get back a polite "my boss doesn't have time for this," meaning that the nice letters we prepared didn't get past the "handlers," or secretaries.

After I polled subscribers to SAR-TALK, respondents universally agreed that the best form of recruitment is to know someone of "importance" and to contact them on a personal level. In my chapter, each member is considered a recruiter. And, it's safe to say that each member of every chapter is also a member of one or more church groups, veteran's associations, historical and genealogical associations, and civic clubs. THAT'S where the recruitment should take place, and THAT'S where notable new members also can be found.

With all chapter members being recruiters, they need to know who in the chapter is willing and capable to sponsor these new members. At least one chapter member needs to be up to speed on researching the ancestry for these interested individuals and preparing their applications for them. In my chapter, it's the registrar. (Recruiters in my chapter may sign as the co-sponsor and pin the rosette on the new member during the induction ceremony.)

Once a notable recruit expresses interest in joining the SAR, it shouldn't be necessary for him to even have traced his ancestry. A good recruiter and a good sponsor will assure the individual that the chapter will do ancestry research for him, with his assistance of course, and that if there is a patriot ancestor in his "tree," then there's a fair chance one will be found, along with the documentation necessary to complete the application.

Here is a real opportunity for us all to do something about our dwindling chapter membership rolls. Chapter presidents: Make a pitch at your next chapter meeting for everyone to become a recruiter. Recruiters: Invite a Revolutionary War-uniformed Philip K. Curtis, Chancellor, GASSAR

member of your chapter to speak at your club meetings. His pitch can include a short segment on the benefits of SAR membership. Our efforts WILL pay off!

Items of Interest from the Leadership Conference of September 26-29, 2009

Center for Advancing America's Heritage National Color Guardsman of the Year - In - The Georgia Society needs about 152 additional members to make a contribution to the building fund to achieve the national goal of 20% participation by the membership. George Washington Endowment Fund -Three percent of the national membership (780) are George Washington Fellows. The **Eighth Grade Essay Contest** – A new fund now exceeds \$1 million.
