#### 2013 Membership Dues

The deadline for 2013 dues, though it seems a ways off, is rapidly gaining on us. Chapters MUST receive 2013 dues before 31 Dec 2012. *ALL DUES MUST BE IN THE STATE SECRETARY'S HANDS ON 10 JAN 2013 (NOT AFTER THE 10<sup>TH</sup>).* If you have not begun to organize your efforts now is the time. The following information will help in that process.

#### **Chapter Directories and Dues Report**

All chapter presidents, secretaries, and treasurers with an e-mail address have received an *updated Chapter Directory* from me. Each **Chapter Directory** has a list of <u>current</u> year paid members with National and State Numbers, address, phone numbers and e-mail addresses as of **01 Aug 2012**. Dual members that do not pay their Georgia Society dues through your chapter WILL NOT be on that Directory. They WILL be on the Directory of their primary chapter. Any dropped members that have requested reinstatement and have yet to be approved and registered by the National Society WILL NOT be on the Directory. You are to treat these dual members and pending reinstatements as current members for your purpose of collecting their 2013 dues. A newly updated Directory will be e-mailed before 01 Nov 2012 and again by 01 Dec 2012.

Each Directory will be accompanied by a **Dues Report** to be used by the Chapter Treasurer when submitting chapter dues. Anytime this fall, **before 31 Dec 2012**, when 2013 dues are submitted the chapter treasurer can "check off" each member as paid and then calculate the total dues submitted at that time. The Dues Report for all currently REGISTERED members will show the exact amount owed. A Dual Member will show \$13 dues owed. A Life Member will also show \$13 owed. Please use the Dues form that is e-mailed (not a handwritten or typed submission).

Once I receive a check and a Dues Report from a treasurer, I will e-mail a new Dues Report to all chapter officers to confirm that 2013 membership dues were paid. This allows time to correct any potential errors before the end of year deadline.

**Do not include dues for unregistered reinstatements or unregistered applicants with this report.** Any applicants for membership or requests for reinstatement will show up on future Dues Reports once registered by the National Society. Any applicant or reinstatement registered *after November*  $I^{st}$  will have their dues automatically credited and indicated on any Dues Report sent to the chapter following their registration. Any applicants or reinstatements that are registered *before November*  $I^{st}$ , their 2013 dues requirements will appear on any Dues Reports sent to the chapter officers.

> Upon several occasions the application principal connections must be defined. First the maiden name of the mother. This can be done through birth or death record of mother naming her parents. Secondly, the connection between the mother and her parents must be established. One source is her death record. The others are her birth record or marriage record naming the bride's parents. On some occasions the marriage connection is made through the bride's father will naming his daughter by the given name and married surname.

> When marking up source documents use a red pen or pencil. Do not use highlighter. The highlighted data cannot be effectively reproduced by a copier. Mark the top of the document in red "Gen. X" or "Gen. X-Y" designating the appropriate generations that applies to the document. Underline the appropriate text within the document with a red pen or pencil and in the margin "Gen. X" as appropriate in red. This facilitates a rapid review of the source documents for lineage verification and connection. On the back of each source document enter the following "Applicant's Surname"/ "Patriot's surname"/ Georgia Society/ "Chapter name". If by accident the material is scattered this aids in gathering the material.

> I suggest that a careful review be made of NSDAR Record Copies submitted as document sources for the application bridging several generations. Review the lineage section of the DAR application along with the source section on the second page by generations. If there is no source cited, the DAR Record Copy may be too old or it refers to an earlier DAR application. In either case further supporting documentation will be required.

> Over two hundred membership or applications have supplemental been processed since February 2012 with few pended at NSSAR due to either flags on the patriot or lack of documentation referenced on earlier applications used as supporting data. Your registrar is also holding several applications for additional documentation to complete the application process.

> In the effort to expedite application approval it is suggested that taking a little time to talk out problems area and developing solutions pays great dividends. There have been several genealogical proof statements developed by chapter registrars to define lineages. approved for membership.

Miss Lily Garnett is our 2012-2013 C.A.R. Georgia Society State President. Her State Theme is "Finishing the Fight".



**Report from Fall Leadership/Trustee Meeting** 



The Georgia Society Members in attendance were: Compatriots Roger Coursey, T.F. Craft, Robert Galer, David Jessel, Bill Kabel, Paul Prescott, Ed Rigel, James Stallings, George Thurmond, Mike Tomme, Robert F. Towns and Robert Wylie. It was Bill Kabel's and Robert Wylie's first time at Leadership.

What follows is a compilation of reports from those who attended and responded to my request to share their opinions on the actions at Fall Leadership.

PG Leishman asked that the minutes from the Committee meetings be submitted as soon as possible for posting to the web. The significance is that members will not wait 6 months, when the next semi-annual reports come out at March Leadership, to find out what went on in September.

**Medals and Awards** approved several new Medals – Molly Pitcher – National Medal for Camp Followers; Thomas Jefferson Knight Essay Medal – Contributors to the Knight Essay Endowment Fund; Patriot Grave Marking Medal – For participating in grave markings. Qualifications for these medals should come out soon.

**IT Committee** is in the process of developing the ability to fill out new member applications on-line. Log on, start filling out, save and come back to. Others can log in and contribute. Will not reduce paperwork, but all the information entered would be entered into a searchable database such that all data in new applications would be available going forward.

**Operation REACH** (Reaching Every American Compatriot at Home).New Program in conjunction with Ancestry.com. Trial program with two large state Societies. Ancestry.com informs their subscribers that they have possible ancestors that appear in an SAR application in their database, that they might be eligible for membership in the SAR, and provide a state SAR point of contact.

The old **WW II Veterans Corps Committee** is now renamed the **Veterans Recognition Committee** and will start recognizing Veteran's of the Korean War. Recognition of WW II Vets is being phased out.

CAAH has raised over 9 million of its goal of 10.5 million.

Americanism Poster Contest theme will be announced in rolling five year increments and will focus on three elements of the theme; i.e., person, place and event.

**Newsletter** Chapters who publish should enter the NSSAR competition by mailing two issues to Chairman Steve Pittard at 414 Wilde Drive, Fayetteville, NC 28314.

**Merchandise.** Remains very active in supporting the SAR with new items. Would prefer to ship bulk to states, saving shipping time and money by the staff. Susan Griffin is easy to work with, so contact her if you have a question (502-589-1776 X 6141). Merchandise has earned \$30,000 towards the NSSAR operating budget from sales.

**Revolutionary War Graves / Patriot Index.** A medal for grave marking has been approved. A reporting form has been developed to record these events and will be on the NSSAR web site. Volunteers are needed to assist in recording graves marked for the Patriot Index. If you can help by entering data on your computer, contact Chairman Michael Keen, 302-222-8157, <u>mkphoto44@comcast.net</u>. A Patriot Grave Marking Manual has been developed.



On August 27<sup>th</sup>, the Piedmont Chapter of the Sons of the American Revolution awarded eight-year old Cooper Davis with a

medal and certificate commemorating his heroism in rescuing another child from drowning. Cooper, who was age 7 at the time of the rescue, was vacationing with his family in California and had been swimming laps in the hotel pool, when he saw a boy face down at the bottom of the swimming pool.

Cooper immediately swam to the bottom of the pool, grabbed the unconscious boy under his shoulder and swam him to the surface one-handed. Upon reaching the surface, Cooper realized the boy's mouth was still underwater, so he was able to flip him over in the water, and then swam him to the side of the pool. Cooper was trying to push the boy, who was also age 7, up and out of the pool, when another child shouting for help caught the attention of Jeff Davis, Cooper's father. Jeff pulled the boy out of the pool, and after determining that he was not breathing, Jeff and another bystander performed CPR and were able to revive him.

Cooper was given a medal for courage by one of the police officers who was at the scene (see photo attached). The California police also contacted local Georgia authorities to tell about the boy's bravery, which has prompted national media attention and an award ceremony by the City of Johns Creek, in which the Piedmont Chapter participated.

## Appling Sword

During the War of 1812 Daniel Appling was sent with his riflemen and some Indians to sneak around a British blockade and deliver the canon needed to build three warships. The British learned of the plan and sent a large force to intercept Appling. Rather than withdraw, Appling his men in the woods along the creek and ambushed the British troops. His small force defeated over 200 British, capturing 143 and the vital warships were supplied. Later in the war, Appling and only 110 riflemen managed to delay 8,200 British troops during the Battle of Plattsburgh. Appling's heroics helped win what is considered the most decisive battle of the War of 1812.

The elaborate ceremonial sword was purchased by the Georgia General Assembly in 1814 to be presented to Daniel Appling, a hero of the War of 1812. Appling died before the sword could be presented, so the legislature voted to keep the sword and display it in the Governor's Office "as a lasting monument to [Appling's] fame, and a grateful proof of the sensibility with which Georgia cherishes the recollection of the patriotic services of her citizens." The sword, forged by the well known firm Fletcher and Gardiner of Philadelphia, contains the inscription "PRESENTED, by the State of Georgia, to her son, the brave and gallant Lieut. Colonel Daniel Appling, of the U.S. Army, for his cool and deliberate valor displayed throughout the action of the 30<sup>th</sup> of May, 1814, at Sandy Creek, when he succeeded in capturing a superior British force."

In 1883 one of the legislators noted that Appling's "sword of honor" was not being cared for adequately and so the legislature voted to deposit the Appling Sword "in the archives of the Georgia Historical Society until the State shall have provided a proper archives department."

In 1906 the legislature retrieved the sword (along with several other artifacts from the Historical Society and sent it to be displayed in Georgia's building at the Jamestown Exposition celebrating its 300<sup>th</sup> anniversary.

No one knows. There is evidence that some of the artifacts were returned from Jamestown, but there is no record of what happened to the sword specifically. The state established an archives in 1918, and the sword should have gone to the archives at that time, but there is no positive proof in either the records of the Georgia Archives or the Georgia Historical Society that this happened. A thorough search of the records shows no mention of the sword after 1907

except in a few notes written in the 1980s conjecturing that the sword may have been lost or stolen.

No one knows for sure how the sword left state custody. It is possible that the sword was removed in a valid manner. The professional practices that govern how a museum or archives removes items from its collection did not develop until the 1970s, so the sword could have been removed from state custody after 1907 in a way that was legitimate at the time.

The Appling Sword was purchased from a reputable antiques dealer for \$100,000. The money was raised from private groups and individuals and has been restored.

On October 15<sup>th</sup>, the Appling Sword to the State of Georgia in a ceremony attended by the State Color Guard.. The sword is now displayed in the Hall of Valor in the State Capital.

"In addition Constitution Day, September 17, 2012. to Kettle Creek, Wilkes County has a watershed of Revolutionary and Colonial assets. Directly associated with the Kettle Creek battle was the siege at Carr's Fort. country is attacked from within?


Will you defend her, as did your founding fathers?

Imagine jumping from an airplane in flight, counting off four seconds, then deciding if the reserve parachute needs to be deployed or not. This July 2012, two compatriots found themselves completing a nine day parachute course with the WW II Airborne Demonstration Team (ADT) at Frederick Army Airfield, Oklahoma. CPT Patrick Kelly, USN ret, VAS SAR, and LTC Bloise A. Hill, USA ret, GAS SAR were members of the WW II ADT Class 2012-02 "Kelly's Heroes." After a prayer, the 19 man class completed their final 5<sup>th</sup> jump in WW II OD uniforms, from a 68 year old C47A aircraft, "Boogie Baby," that had jumped troopers into Normandy in 1944.

Prior to jumping practical and written tests were given on parachute landing falls, emergency procedures, and proper door exiting. The course was professionally taught by an outstanding cadre. A typical day started at 0530 hrs. with intense instruction following, a lot to cover in a few days. The class quickly became a unit with a common purpose. The average age was 50, students had all sorts of backgrounds were from around the country (one was from Belgium), but all had one thing in common, a deep love of history.

For graduation, the ADT hosted Open Hanger and Fly-In attended by over 300 people. Jump wings were pinned on by COL Steeley, WW II ADT CDR, and CSM Harrington assisted by WW II parachute veterans, some who jumped into Normandy and Operation Market Garden in 1944.

The WW II ADT 1<sup>st</sup> SGT, retired Special Forces soldier Richard Wolf said, "this organization exists as a tribute to the WW II veteran, and all the veterans of this great country."
