Membership and Reinstatements:

The Georgia Society had 180 members who failed to renew their membership for 2013 and have been dropped from National and Georgia Society rolls. Our Society membership was 1,654 on 31 Dec 2012 and, due to membership drops, is now 1,474 as of 01 Jan 2013.

Those members who have been dropped may be reinstated by sending National, State, and Chapter dues to their chapter treasurer: \$30 National, \$13 State, plus Chapter dues. No form is necessary. The chapter treasurer needs to send a list of member reinstatements that give name, National and State numbers, and any change of address or phone numbers.

If a member's recent membership was in another state, Form 0918 is required along with a check for dues payment. A RECORD COPY is required when submitting this form. Should the member not have one, an additional \$10 must be submitted to cover the cost of acquiring one from National.

PLEASE NOTE: All reinstatements submitted will be held until 01 Mar 2013 as State Secretaries and National complete the Reconciliation process.

IRS Forms 990 and 990-N:

President Rigel recently sent a message to the BOM regarding IRS Forms 990 and 990-N.

One of these forms must be filed every year by the 15th day of the fifth month after the chapter's fiscal year. For most chapters this is 15 May.





TRUST, FAITH, HONOR

Recently, I had a conversation with a minister who had signed a renewal agreement lease for his church. Having dealt with the landlord for five years, and deemed friendship was in place, he did not read the lease. As the bi-annual payment was made to the one year agreement, he was told that the rental rate had increased. When protesting this increase without his consent or consultation, he was told that he should have read the lease before he signed it. And that's right, he should have read it, and would have discovered a clause that allowed the landlord to invoke increases. He should have sat there and taken the time, at the landlord's expense, to read that contract. How many times have you signed something you didn't read? How many times have you discovered a bit of information that you needed that another individual had and knew that you needed, only to be told, "Well, you didn't ask."

How sad. How sad the minister must feel for having been taken advantage of without any warning. How sad that trust and faith has been subverted. How sad that an individual's outlook and attitude towards his fellow man has been changed forever, and to be suspicious of others. How sad that the landlord has no sense of honor, knowing the lease had changed, and knowing – but not pointing it out.

Message From the Georgia Society Registrar

The Georgia Society closed the calendar year 2012 by submitting a total of 254 membership and supplemental applications

since February 2012. Due to various circumstances your State Registrar's review and approval time from receipt of applications has stretched to 4 to 6 weeks. The last applications received in 2012 were mailed to the Society's Secretary on 3 January 2013. Of the applications reviewed, six were held for additional material and two were withdrawn. Of the applications submitted to NSSAR for approval to date eight were pended at the end of the year. Three were for proof of service, three for proof of identity, and two for DAR reference data. The year end pended total is 15.

In March 2011 NSSAR indicated that the Georgia Society had 81 pended applications, several of which were three years or older. Through the diligent efforts of Compatriot Mike Tomme and Larry Guzy as Assistant Registrars that number has been reduced to only four outstanding. Three pended applications were added this year as carry over from 2011 submittals. The attention and review by the first line signers and chapter registrars has lead to a higher approval of applications this year. Thanks go to those who contributed to this effort.

The NSSAR Genealogy Committee has issued two documents for preparing applications and policies. These documents are a compilation of past approved practices. However, the preparation of an acceptable application is dependent upon interpreting the documents that support the lineage and the patriot's service.

Your Registrar is becoming more aware that the Georgia Society members are in need of three things that can only be provided through a guide book and a training session. These are 1) the minimum documents required to prepare an application; 2) the presentation statements that interpret and define lineage and 3) training sessions with chapter registrars. With your help in Q&A dialog a collection of notes and examples can be generated to provide guidelines for application preparation. Your Registrar has started collecting proof statement examples and notes for data request that will provide a good base for review.

Next year's applications quality will be dependent upon how well your Registrar has communicated with you on requirements and interpretation of data.

Your Registrar serves at the pleasure of the State Society and is your most humble servant.

Immediate Past President's Final Ramble

One just never knows. In my last "Ramble", in October, I laid out all the plans for my last quarter as President. Two weeks later and Burns' "gang aft agley" became not just a quote, but a reality. Given the demographics of our Society, allow me to share my lesson learned. Compatriots, despite what we might think of ourselves, we are not invulnerable. Refresh in your mind the signs and symptoms associated with angina or a heart attack and then pay attention to them should they occur. Should you experience symptoms, inform your spouse. She is less likely to be convinced of your invulnerability and more likely to stimulate you to take appropriate action. And on the subject of spouses, signs and symptoms of a heart attack are different for females. I recommend that the two of you research that matter and keep your findings in mind.

Well, I was lucky. I ignored what was in my trained physician's mind definitely NOT cardiac pain for about 45 minutes before getting nervous enough to call 911. An electrocardiogram demonstrated how much I knew and quick intervention limited the damage to my heart. Three weeks later, another three stents, and I had a new heart. I am in my second month of Cardiac Rehab and doing very well including making the appropriate changes in lifestyle that might prevent a reoccurrence.

Sincere thanks for all the thoughts, prayers and other expressions of concern. They were all deeply appreciated by Joan and me. Enough Dr. Oz. It was the Vann's Creek event (killed me to miss the BOM meeting in October!) before I could really get back in the saddle. I participated with a large contingent of the Color Guard and brought greetings from the Society. Great speaker! A few days later I visited the William Few Chapter at their Christmas dinner. After an impromptu installation of new officers, I gave my old standby, "Reluctant Rebels – GA in the Revolution" program. That Chapter has an enthusiastic core and I look forward to hearing more from them in the near future.

Down to Conyers at the end of the week to have supper with the George Walton Chapter. A small and delightful group that does more than you would expect from a group their size. Christmas supper with the Athens Chapter followed their typical hospitality in the home of Compatriot Guest. Compatriot Terry Manning gave a most entertaining program on the history of Santa Claus to wrap up the evening. Vann's Creek

"Most people think nothing ever happened where they are," historian Ann Lee Caldwell

told a gathering on December 1, 2012.

"But all history is local," she told the crowd of about 50 at Richard B. Russell State Park in Elbert County, Ga. "It all connects. And this small battle in the backcountry became a link in the chain of events that founded America."

Caldwell, a history professor at Augusta State University and a specialist in colonial history, was the keynote speaker at a commemoration of the Feb. 11, 1779, Battle of Vann's Creek. The battle saw a patriot force of about 100 men commanded by South Carolinian Robert Anderson oppose the crossing of the Savannah River by an estimated 800-man force of loyalists from the South Carolina upcountry.

Marking little-known battles such as that at Vann's Creek serves an especially important purpose in today's world, according to Steve Pittard, Vice President General of the Southeast District of the National Society of the Sons of the American Revolution, who attended the ceremony Saturday.

"Very little of the period is taught in our schools these days," Pittard said, "little about why the people fought and what they fought for, little about our founding documents. This is why the Sons of the American Revolution has taken up the challenge of doing it."

Prison Ships of the Revolutionary War

"Rebels, turn out your dead!"

American prisoners during Revolutionary War, housed in abandoned war ships, woke each morning to this command by their jailers. Some of the prisoners were captured in battle. A few were arrested for serving on American controlled privateers. One-third were imprisoned for simply

refusing to swear an oath of allegiance to the Crown. These notorious warships, sixteen in all, were kept in the waters near New York Harbor. More Americans - over 11,000 died on these floating dens of vermin, pestilence, and hunger than died in battle.

The worst of these prison ships was the Old Jersey. Stripped of all ornamentation and rigging, her dark and dirty appearance echoed the death and despair within. Nicknamed "Hell" by her inmates, she housed over 1,000 men at any one time. While the prisoners were allowed above board during the day, at dusk they were forced down into the bowels of the ship by the point of a bayonet. Unanswered pleas for water wailed throughout the night. Yellow fever, small pox, and dysentery raged through the ship, greedily taking their full share of victims. Derangement, brought on by disease or the crushing confines of the crowded lower deck, turned the soldiers into mad men, driven wild with despair. Every night, a dozen or so men died, their corpses thrown onto the surrounding mud flats each morning. According to Thomas Andros, a survivor of the Old Jersey, it was common to lie down next to a man in the evening, only to wake up beside a corpse. General Washington in a letter to Lord Howe, the chief of British forces, called the prison ships "cruel and unjustifiable" and called for relief. His letter went unanswered.

There were a few ways off the prison ships. A handful of prisoners had sufficient funds to buy their way off. Limited prisoner exchanges existed between the Americans and the Redcoats - officer for officer, soldier for soldier. The British dangled an enticing offer in front of the suffering men. Any prisoner promising to join the British forces would be released immediately from the confines of the prison ships and turned over to serve in the Royal Navy. Love of our fledgling country prevailed, though. While a few prisoners did accept the British offer of freedom in return for service, most chose loyalty to the cause of freedom. Their departure from the prison ships came by death.

On July 4th, 1782, with the war's end in sight, the emaciated prisoners of Old Jersey celebrated their new nation. The outraged British guards, unable to silence their captives' joy, lashed out, hacking and wounding every prisoner within reach. Forcing the bloody, battered men down into the lower deck, the guards locked the hatch, leaving the men to suffer and perish.

Many died that night in the depths of Old Jersey, but their unrelenting spirit and belief in liberty remain a beacon to our nation's quest for independence.

Button Gwinnett

As part of a fundraiser for the Louisiana State Museum in New Orleans, Michael N. Henderson, president of the Button Gwinnett Chapter, Georgia Society SAR spoke to an audience of historians and researchers who gathered for "A Records Review: Colonial Documents Going Digital." The event was Claud Brunet, counsel General of France and Michael held to raise awareness and \$1.5 million to Henderson, President of the Button Gwinnett Chapter support the museum's Colonial Documents Digitization and Online Publication Project. This multi-year effort to preserve the records' contents for all posterity will, once complete, enable unprecedented access to the archive by researchers from around the globe.

President Henderson shared how he utilized the colonial records, along with other resources, to locate documents to complete his SAR application package and was American Revolution in 2010. "I stand as a living memorial of the importance of making these valuable documents available and accessible to a broad audience," said Henderson. His patriot ancestor's story was captured in a segment of the PBS program, "History Detectives," titled the "The Galvez Papers."

"My hope is that others from around the country and the world will be able to access these documents and themselves make a connection to their Revolutionary War ancestors, particularly those who served in colonial Louisiana," he added.

The records of the French Superior Council (1714-1769) and Spanish Judiciary (1769-1803) comprise the bulk of the Louisiana State Museum's colonial documents collection and are the oldest nonsacramental records in the entire Mississippi Valley. The 70,000 court cases and notarial agreements (about 220,000 pages) tell thousands of individual stories, which, taken together, document the daily life of Louisiana's first permanent European and African inhabitants, as well as aspects of their relations with allied and enemy Native tribes. The archive is a national treasure that contains an abundance of information for

The program was presented by Milus Bruce Maney, the Northeast Regional Vice President concerning one of the 30 forts of Wilkes County - Fort McClusky.

Compatriot Maney, while studying his family genealogy, had found a document in the Georgia Archives from the Revolutionary War written by General Elijah Clarke. General Clarke wrote of an Indian attack, during which horses were stolen from Fort McCluskey on the Broad River. Compatriot Maney said the river stretches 70 miles, so the location of the fort based on that description is vague. But he was better able to narrow the location with another document he found in the Georgia Archives. Part of Madison County was originally part of Wilkes County formed from the Ceded Lands in 1774 by the Cherokee and Creek Indians, and one report shows over 30 forts (most of these are not located now-lost).

A present study by archeologist Dan Elliott on the location of Carr's Fort, about 2-5 miles from Kettle Creek, is attempting to locate Carr's Fort and hopefully will began locating the other lost forts of original Wilkes County, which would include Elbert County, Lincoln County, Oglethorpe County, and parts of Warren County, Taliferro County, Oglethorpe County, Hart County, Green and McDuffie Counties.

Forts were built to protect the settlers from hostile attacks from Indians and Tories who supported the British. (Washington, Georgia was originally Heard's Fort-named after John Heard and sons Stephen and Barnard.)

2013-2014 Regular Session - HB 133 Property easements; rights of way across private land for the purpose of access to cemetery sites

First Reader Summary

A BILL to be entitled an Act to amend Chapter 9 of Title 44 of the Official Code of Georgia Annotated, relating to property easements, so as to provide for rights of way across private land for the purpose of access to cemetery sites; to provide definitions; to establish notice procedures; to provide for **immunity from liability for landowners**; to provide a cause of

action; to amend Code Section 36-72-4 of the Official Code of Georgia Annotated, relating to permits required for developing land on which a cemetery is located, so as to prevent certain activities on cemeteries and burial sites without a permit; to provide for related matters; to repeal conflicting laws; and for other purposes.

A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 9 of Title 44 of the Official Code of Georgia Annotated, relating to
- 2 property easements, so as to provide for rights of way across private land for the purpose of
- 3 access to cemetery sites; to provide definitions; to establish notice procedures; to provide for
- 4 immunity from liability for landowners; to provide a cause of action; to amend Code Section
- 5 36-72-4 of the Official Code of Georgia Annotated, relating to permits required for
- 6 developing land on which a cemetery is located, so as to prevent certain activities on
- 7 cemeteries and burial sites without a permit; to provide for related matters; to repeal
- 8 conflicting laws; and for other purposes.
- 9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 SECTION 1.

- 11 Chapter 9 of Title 44 of the Official Code of Georgia Annotated, relating to property
- 12 easements, is amended by adding a new article to read as follows:
- 13 "ARTICLE 2A
- 14 44-9-30.
- 15 As used in this article, the term:
- 16 (1) 'Cemetery' means a place dedicated to and used for permanent interment or
- 17 inurnment of human remains and may consist of a burial park for earth interments, a
- 18 mausoleum for vault or crypt interments, a columbarium for inurnments, or other similar 19 structures.
- 20 (2) 'Descendant' means a person or group of persons related to a human by blood or
- 21 adoption in accordance with Title 19.
- 22 (3) 'Family member' means a spouse, child, sibling, parent, grandparent, or grandchild.
- 23 44-9-31.
- 24 (a) Owners of private property on which a cemetery is located shall grant access to such 25 cemetery to:
- 26 (1) Any family member or descendant of any deceased person whose remains lie within 27 the cemetery;
- 28 (2) Any owner of the cemetery; or
- 29 (3) Any person responsible for maintenance of the cemetery.
- 30 (b) Access to such cemetery shall include ingress, egress, and regress, but only for the
- 31 limited purposes of maintaining the cemetery for its intended use, honoring persons buried
- 32 at the cemetery site, or conducting genealogical research.
- 33 (c) A landowner granting access pursuant to this article may supervise ingress and egress 34 across the property.

- 35 44-9-32.
- 36 (a) Any person seeking access across private land pursuant to Code Section 44-9-31 shall
- 37 provide to the landowner prior notice of intent to enter the land.
- 38 (b) Prior notice of intent to enter must be received by the landowner at least 14 days prior
- 39 to the proposed date of entry; provided, however, that if the landowner is a utility provider,
- 40 notice must be received at least 30 days prior to the proposed date of entry. Upon receiving
- 41 proper notice, the landowner shall allow access on the proposed date or on any other date
- 42 agreeable to both parties.
- 43 (c) No landowner shall be required to grant access under Code Section 44-9-31 if:
- 44 (1) Prior notice under this Code section is not given;
- 45 (2) Public access to the cemetery site is otherwise available;
- 46 (3) The person seeking access is able to reach the cemetery site by way of his or her own

- 48 (4) The requested access is unreasonable with regard to hour, duration, or manner of
- 49 travel across the land.
- 50 44-9-33.
- 51 A landowner who grants access pursuant to this article shall be immune from civil liability
- 52 for damage and injuries which may arise from such access, provided that the conduct of the
- 53 landowner does not constitute gross negligence or willful and wanton misconduct.
- 54 44-9-34.
- 55 (a) If a private landowner denies access to a cemetery in violation of this article, such
- 56 violation shall constitute a private nuisance; and any person injured thereby is authorized
- 57 to seek, in the superior court with proper jurisdiction, an injunction enjoining such
- 58 landowner's further violation of this article.
- 59 (b) An action for injunction brought pursuant to this Code section may be maintained
- 60 notwithstanding the existence of other legal remedies.
- 61 (c) A landowner who continues to deny access after a court has given notice to abate
- 62 pursuant to this Code section shall be guilty of a misdemeanor."
- 63 SECTION 2.
- 64 Code Section 36-72-4 of the Official Code of Georgia Annotated, relating to permits required
- 65 for developing land on which a cemetery is located, is amended as follows:
- 66 "36-72-4.
- 67 No owner or occupier of land shall knowingly disturb any known cemetery, burial ground,
- 68 human remains, or burial object shall be knowingly disturbed by the owner or occupier of
- 69 the land on which the cemetery or burial ground is located for the purposes of developing
- 70 or changing the use of any part of such land by developing, allowing livestock to graze
- 71 upon, or similarly interfering with such cemetery, burial ground, human remains, or burial
- 72 object unless a permit is first obtained from the governing authority of the municipal
- 73 corporation or county wherein the cemetery or burial ground is located, which shall have
- 74 authority to permit such activity except as provided in Code Section 36-72-14."
